ORDER:

The Vice-Chancellor, after having considered the minutes 1st and 2nd cited, has ordered as follows:

1. The existing syllabus of M.A. Rural Development be continued for the Academic Year 2017-18.
2. The existing pattern of Question Papers for M.A. Rural Development semester examinations be continued.
3. The panel of Paper Setters-cum-Examiners recommended by BoS be approved.
4. The panel of Subject Experts for the appointment of teaching posts recommended by BoS be approved.
5. The existing syllabi and pattern of Model Question Paper be continued for Part-I M.Phil/Pre-Ph.D. examination.
6. The existing pattern of examination consists of 30 marks internal exams and 70 marks semester-end exams be continued.
7. The introduction of MOOCs from the Academic Year 2017-18 be approved.
8. To proposal of making the students to participate vigorously in social service activities as a part of the curriculum of M.A. Rural Development be approved.
9. The journals which have not been included in the UGC list of journals released in April, 2017 be identified to retransmit the same to the UGC for inclusion.

Further, the Vice-Chancellor has ordered that the students should register for two MOOC courses, which shall not be less than three months duration, one in II Semester and the other in III Semester either from the SWAYAM platform (MHRD) or from the University website (list of courses identified by the concerned Department) and to allot 4 credits for each MOOC (2x4=8 credits) and submit the marks to the Controller of Examinations, ANU through the Head of the Department for incorporating the same in Marks Memo and Consolidated Marks Memo (CML).

Also, the Vice-Chancellor has ordered that students be permitted to opt more than one MOOC course in II and III Semesters of M.A. Rural Development course WITHOUT credits but the particulars of the course(s) completed by such students be printed in the marks lists and CML respectively.
