APPGECET-2020 SPOT ADMISSIONS IN UNIVERSITY

Guidelines:

1. Candidates who have not taken admission so far are only eligible. Candidates shall not be allowed for spot admission without original certificates.
2. The vacancies are to be filled with those qualified in APPGECET-2020 possessing eligibility as prescribed for APPGECET-2020.
3. Candidates who satisfy the definition of Local / Non-Local shall alone be granted admission. Candidates whose qualifying examination is from other state [For this purpose, Telangana is not other state] but either of the parents resided for a period of 10 years in A.P. / Telangana state are eligible for Spot Admissions.
- 4. Certificates to be Verified:**
 - APPGECET-2020 Hall-Ticket, Rank Card
 - Transfer Certificate
 - Qualifying Examination Consolidated Marks Memo and Provisional Pass Certificate / Degree Certificate.
 - Eligibility for admission into a branch shall be as per the affiliating University concerned.
 - Study Certificate.
 - Residence Certificate.
 - Caste Certificate
 - Aadhar Number/Any Govt .Id.
5. Produce the Xerox copies of all above certificates for Verification and for ratification of spot admissions made.
6. All the Vacancies may be treated as Open Category and Candidates are to be considered purely on Merit order for these seats.
7. Please Note that the Students admitted through Spot Admissions (i.e.) leftover seats of the Convenor quota in the institutional Spot Admissions are not eligible for Jagananna Vidya Deevena and Jagananna Vasati Deevena.
