GUIDELINES:

- The vacancies under Spot Admissions shall be filled with candidates **qualified in AP LAW CET-2022 and satisfying the required percentage in qualifying exam.**
- Candidates who have not taken admission in Convener Quota so far are only eligible.
- Candidates possessing the qualifying examination certificate from BCI approved institution shall alone be considered for admission.
- Candidates shall not be allowed for spot admission without original certificates.
- Certificates to be Verified:**
 - ❖ APLAWCET-2022 Hall-Ticket & Rank Card
 - ❖ Transfer Certificate from last studied course
 - ❖ Qualifying Examination Consolidated Marks Memo and Provisional Pass Certificate / Degree Certificate.
 - ❖ Eligibility for admission into a branch shall be as per the rules & regulations university concerned.
 - ❖ Eligibility for admission into a course shall be as prescribed educational qualifications given in APLAWCET-2022 Notification.
 - ❖ SSC marks memo or equivalent.
 - ❖ Intermediate marks memo or equivalent.
 - ❖ Study Certificates from IX class to Degree / Residence Certificate.
 - ❖ Caste Certificate (if candidate belongs to BC/SC/ST)
 - ❖ Aadhar Number/Any Govt .Id.
 - ❖ Passport Photos-3
- Produce the ONE set Xerox copies of all above certificates for Verification and for ratification of spot admissions made.
- All the vacancies are to be considered purely on **merit order** (APLAWCET-2022) for these seats.

Important Note:

- The Vacancies will be filled by LAW CET-2022 rank holders only as first priority on merit.
- Spot Admissions candidates are not eligible for Tuition Fee reimbursement vide G.O.Ms.No.66, SW-Edn, Department, dated 08-09-2010 and JAGANANNA VIDYA & VASATI DEEVANA SCHEMES.
- Medical Fund of Rs. 240/- will be paid at Principal's Office, ANU along with processing fee to be paid to APSCHE.
