- Transfer Certificate from last studied course
- Qualifying Examination Consolidated Marks Memo and Provisional Pass Certificate / Degree Certificate.
- Eligibility for admission into a branch shall be as per the affiliating University concerned.
- SSC marks memo or equivalent.
- Study Certificates from IX class to Degree.
- Residence Certificate.
- Caste Certificate (if candidate belongs to BC/SC/ST)
- EWS Certificate
- Principals are requested to collect from each candidate admitted through Spot Admissions the following processing fee
- 3. Produce the one set Xerox copies of all above certificates for Verification and for ratification of spot admissions made.
- 4. All the vacancies may be treated as **Open Category** and Candidates are to be considered purely on **merit order**.
